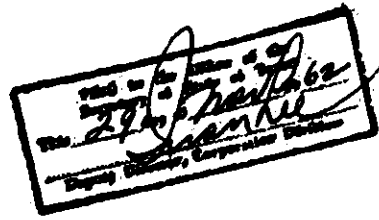

ARTICLES OF INCORPORATION

of

COUNTRY COFFEE COMPANY



We, the undersigned natural persons of the age of twenty-one years or more, at least two of whom are citizens of the State of Texas, acting as incorporators of a corporation under the Texas Business Corporation Act, do hereby adopt the following Articles of Incorporation for such corporation:

ARTICLE ONE

The name of the corporation is COUNTRY COFFEE COMPANY.

ARTICLE TWO

The period of its duration is perpetual.

ARTICLE THREE

The purpose or purposes for which the corporation is organized are: to make, process, buy, sell and otherwise deal in coffee, tea, condiments and food products.

ARTICLE FOUR

The aggregate number of shares which the corporation shall have authority to issue is Twenty Thousand (20,000) Common shares of the par value of Ten Dollars (\$10.00) each.

ARTICLE FIVE

The corporation will not commence business until it has received for the issuance of its shares consideration of the value of Seventy-Five Thousand Dollars (\$75,000.00), consisting of money, labor done or property actually received, which sum is not less than One Thousand Dollars (\$1,000.00).

ARTICLE SIX

The post office address of its initial registered office is Republic National Bank Building, Dallas, Texas, and the name of its

initial registered agent at such address is C T CORPORATION SYSTEM.

ARTICLE SEVEN

The number of directors of the corporation may be fixed by the by-laws, but shall not be less than three (3).

The number of directors constituting the initial board of directors is five (5), and the names and addresses of the persons who are to serve as directors until the first annual meeting of the shareholders or until their successors are elected and qualified are:

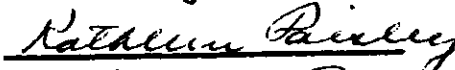

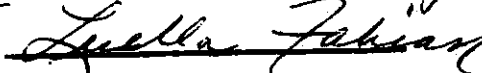
